The undersigned is directed to say that in pursuance of the recommendation made by the Forth central Pay Commission. The question of grant f incentive on acquiring higher qualification was considered by the Government & a centralised committee consisted. The Ministries / Departments of Government of India were advised vide the department O.M. Of even number dt. The 28th June 93 that from the financial year 1993-94, the present system of giving advance increments shall be replaced by grant of lump-sum amount as Incentive. Policy guidelines were also provided to consider grant of lump-sum incentive for acquiring fresh application for which presently there is no scheme for grant of advance increments. The Ministries / departments were requested to review the existing scheme in the light of the aforesaid guidelines.

On the basis of information receive from various Ministries / Departments the matter was considered by the Government and standardised scales of lump-sum incentives issued vide O.M. of even number of the 31st Jan 95. The question of finalising fresh qualifications (in addition to the ones which presently qualify for grant of this incentive) which would meant grant of lump-sum incentives was considered by the centralised committee and after taking into account the recommendations made by the Fifth Central Pay Commission in Chapter 23 of the supplementary report No. I. It has been decided to grant lump-sum incentive on acquiring fresh qualifications listed in the annexure. The grant of incentive in respect of the these qualification will be subject to fulfillment of the criteria laid down in this departments OM dt. 28th June 93 (referred to above.)

The incentive will both be available for the qualifications which are laid down as essential or desirable qualifications in the recruitment rules for the post. The quantum of incentive will be uniforms for all posts irrespective of their classification of grade of the department. The incentive will not be admissible where the government servant is sponsored by the government or he avails of study leave for acquiring the qualification. The incentive would be given only for higher qualification acquired after induction in to service and will not apply for the incentives now being given in the existing schemes for possession of higher qualification at an entry stage. No incentive would be admissible if an appointment is made in relaxation of the educational qualification. No incentive would be admissible if the employee acquires the requisite qualification for such appointment at a later date.

The acquisition of the qualification should be directly related to the functions of the post held by him I her or to the functions to be performed of the post and the qualification acquired and that it should be recognised by the All India Council for Technical Education, Department of Electronics, Deemed University, University or recognised by the Government. No stepping up of pay shall be allowed in the case of juniors by virtue of drawing more pay under the scheme of advance increments.

The grant of incentives for the qualifications listed in the annexure may be considered by the administrative authorities in consultation with their integrated finance and necessary orders issued after ensuring that the criteria laid down at above is fulfilled. The incentive will admissible on acquiring these qualifications on or after the date of issue of these orders.

Should any of the Ministries / Departments consider the extension of the incentive scheme to qualifications other than those listed in the annexure necessary the should be done only with the prior approval of this department and the Ministry Finance.

The Ministry of Agriculture and Co-operation etc. are requested to bring these instructions to the notice of all concerned. In so far as the persons working in the Indian Audit and Accounts Department are concerned these orders issue in consultation with the Controller & Auditor General of India.

As you are aware, All India Council for Technical Education has been mandated under the AICTE Act, 1987 to ensure maintenance of norms and standards with regard to technical education in the country. In exercise of this mandate, the Council insists on fulfillment of the minimum requirements prescribed for imparting technical education by the institution so that quality of courses is not compromised and stakeholders are satisfied. The Council also undertakes an annual inspection of the institutions and conveys deficiencies to them for rectification.

It has been observed however that notwithstanding the Council's repeated advice to comply with minimum norms and standards, many institutions continue to be complacent about taking steps to remedy the deficiencies. Such institutions suffer from critical deficiencies of faculty in proper cadre ratio, qualification, experience and other requirements. Feed back of students with regard to quality of education imparted by such institutions has evoked grave concern. The Expert Committees, following holistic appraisal during inspections, have also pointed out severe shortcomings.

The institution has been found to be suffering from several deficiencies, which are listed in Annexure-A for your perusal. Shortage of faculty is of gravest concern.

The deficiencies in respect of faculty (including proper cadre ration & qualification etc.) could have rendered your institution liab!e for punitive action including being placed in no admission / reduced intake category. However the Council has decided to take a lenient view and give you yet another last opportunity to rectify the deficiencies particularly with regard to faculty shortage, proper cadre ration & requisite qualification. Course-wise approved intake in respect of INDIAN INSTITUTE OF MATERIALS MANAGEMENT, PLOT NO. 102 & 104, INSTITUTIONAL AREA, SECTOR 15, CBD BELAPUR, NAVI MUMBAI - 400 614, your institution for the year 2005-06 is as under:

The above approval is subject to your rectification of deficiencies latest by August end, 2005. A compliance report indicating rectification of deficiencies and details of faculty recruited for each course must be received by the Council, with a copy to concerned Regional Officer latest by 31st August, 2005 to entitle your institution for extension of approval for the year 2006-07.

The compliance report must be accompanied with a visiting / processing fee as prescribed by the Council in the form of demand draft in favour of Member Secretary, AICTE payable at New Delhi. In the absence of the processing/visiting fee, the compliance report may not be entertained.

Following the compliance report, the Council would verify the status in respect of rectification of deficiencies through physical inspection without any prior intimation. The institution should therefore be prepared for random inspection without any prior notice. Extension of approval for the year 2006-07 shall be dependent on the compliance report and the outcome of the surprise inspection.
